Introduction to EPS Security

If your organization is an ECMS Business Partner, your organization's Security Administrator completed the actions identified in the last row of the four color table shown below (page 5). The Security Administrator can add or edit user's access to the ePermitting system (EPS).

PennDOT's ePermitting software is a separate system for applying for PennDOT highway occupancy permits and managing them during the review and approval process. The ePermitting software relies upon the Engineering and Construction Management System's (ECMS) security module for controlling user identification and passwords for ePermitting software. This guide provides step-by-step instructions for creating an ePermitting System Administrator User (ADMIN ID & Password) through ECMS and for the System Administrator to create ePermitting User ID's and passwords.

ePermitting Registration

There are several ways to register for an **ePermitting** User ID:

- **ECMS Business Partners**
 - If you are 1) a business seeking to become an ECMS business partner to use **ePermitting** and other software or services on a regular basis, or 2) a Municipality or County Planning Commission interested in receiving electronic notifications of particular driveway application review activity within their jurisdictions, there is a two-part registration process – a paper registration agreement and an electronic registration form. A Security Administrator will be assigned to manage the employees' access and privileges.
 - Existing ECMS business partners that conduct regular business with the Commonwealth have assigned Business Partner IDs. An assigned Security Administrator in the company has the authority to create multiple user accounts. The Security Administrator can create a user Login ID for you or add **ePermitting** privileges to your existing Login ID.
- **ePermitting Business Partners**

Companies with multiple employees who will use only **ePermitting** can apply for an ePermitting business partner ID. A Security Administrator will be assigned to manage the employees' access and privileges.
- **Single-User ePermitting ID (Express Login)**

Designed for single users who do not work with Highway Occupancy Permits, Express Login allows you to create an account quickly. There are limitations such as not being able to obtain a billing account or receive invoices.

ECMS Business Partner

If your organization is not an ECMS Business Partner, registration process includes a paper registration agreement and an electronic registration form. In addition to being able to use other software or services, by registering as an ECMS Business Partner, Municipalities and Planning Commissions can take advantage of: 1) viewing all ePermitting driveway applications submitted to PennDOT, through all stages of review, issuance, and post issuance and 2) setting-up and maintaining a profile unique to each municipality and planning commission so PennDOT can provide electronic notifications of particular driveway application review activity within their jurisdictions.

Applying for ePermitting Access

If your organization is an ECMS Business Partner, the Security Administrator can add or edit user's access to EPS.

1. Click this link

 or copy it to a web browser to access the ePermitting registration information page.
2. Read the How to Apply instructions for the ECMS Business Partner Account Type.
3. Click the request letter link. The request letter sample opens.
4. Copy the letter into your company letterhead and provide all the highlighted information.
5. Print the letter and have it signed by an authorized representative.
6. Email the letter to: RA-pdECMDSecurity@pa.gov.

Applying for ePermitting Security Administrator Access

1. Click this link

or copy it to a web browser to access the ePermitting registration information page.

2. Read the How to Apply instructions for the ePermitting Business Partner Account Type.

3. Click the ePermitting Business Partner form link. The application form opens.

4. Complete the form and check the ePermitting Business Partner Security Administrator check box.

5. Print the form and have it signed by an authorized representative.

6. Email the completed form to: RA-pdECMDSecurity@pa.gov

Note: You should receive a response from PennDOT within three business days that will include your User ID and password as Security Administrator. Incomplete forms may cause a delay in receiving your Security Administrator ID and password. The two most common are not having a signed form and missing Federal ID information.

Becoming a PennDOT ePermitting Business Partner

Single-User ePermitting ID (Express Login)

Express Login provides a fast way to create a new ePermitting user account. It is recommended for small companies and individuals who do not work with Highway Occupancy Permits frequently. Express Login creates a single-user account that enables you to apply for a permit online, review the application status, and receive correspondence by email. NOTE: A billing account cannot be created for permit or inspection fee invoicing with this type of login.

Existing business partners in the Engineering and Construction Management System (ECMS) should not use Express Login. If your company is already an ECMS business partner, contact your Security Administrator for a logon ID within your Business Partner account.

Creating a Single-User ePermitting Login ID

To create a new ePermitting Business Partner ID and password, simply complete the contact information and create a Login ID and Password.


7. Click the link on the introduction page for Express Login. The Create New User Account screen displays. You must complete the information fields marked with flags to create your account. Click the fields or press Tab to enter the required information.
8. Enter the name of the business owner who is applying for a Business Partner ID. Do not enter the name of another person.
9. A User ID is a unique identifier that enables you to access ePermitting. Type a User ID with up to 15 letters or numerals. Do not use spaces or punctuation. If the User ID you enter already exists, you will be prompted to create a different ID.
10. Type and retype your password in the fields. Passwords must contain at least one numeral and one letter. They must be six characters long or more.
11. For your security, an encrypted string of letters and numerals is displayed to verify your entry. Type the characters as they appear in the encryption window below the field. If the letters are too blurred to recognize, click Reload Image to view a different set of letters.
12. After you have completed the required fields, click the "Create Account" button in the upper toolbar. The system will prompt you if information is missing or the fields are entered incorrectly.
13. EPS confirms that you have created a new account successfully. Two emails are sent to the email address you supplied. The first confirms your User ID. The second confirms your password. To begin using ePermitting immediately, click the link. The Login screen displays.

Setting up an Administrator Account

After receiving an email with administrator information, the administrator must create an administrator account for himself before setting up other users in the organization.

1. Click this link
<http://www.dotdom2.state.pa.us/>
or copy it to a web browser to access the ECMS Login page.
2. Enter your User ID and Password.
3. Click GO. A popup displays requesting that a Security Question and Answer be created.
4. Enter a security question and answer.
5. Click OK. A prompt for you to change your Administration ID password displays.



Note: Passwords must be at least 6 characters and must contain at least one numeral. Passwords are case sensitive.


6. Enter a new password and reenter it to confirm.
7. Click Submit. A message with an OK button displays.
8. Click the OK button to complete administration setup.

Note: In addition to the ADMIN ID, you will need to create a User ID for yourself. This can be done without logging off of the system. Follow instructions for Creating a User ID and Password.

Creating a User ID and Password

The EPS Security Administrator can create User IDs for members of the organization who need access to ePermitting. The Administrator should also create one for him or herself. The Security Administration ID and Password should only be used to add and maintain organization users. For all other transactions, log in with the normal User ID and Password.

1. Click this link <http://www.dotdom2.state.pa.us/>, or copy it to a web browser to access the ECMS Login page.
2. Log in using your Administrator User ID and Password.
3. Select the "Administration" menu button.



Logging on as an ePermitting User for the First Time

Once your ePermitting User ID has been created, the first attempt to log in to EPS will result in a prompt to change the assigned password. After this is accomplished, you will be able to log in to EPS.

1. Open the ePermitting login page.
2. Enter your User ID and Password.
3. Click Login. A prompt to change your password displays.
4. Click the Access ECMS link. The ECMS change Profile Information screen displays.
5. Enter your current password, then enter and verify a new password.



- Note:** Passwords must be at least 6 characters long and must contain at least one numeral. Passwords are case sensitive.
6. Click the Submit button when finished. A prompt displays with verification that the change was successful.
 7. Click the PennDOT Systems button and select the EPS quick link to open the EPS login page.

Administration Maintenance

A Security Administrator can create, edit and delete the security settings for EPS users.

1. Log in with the Security Administrator User ID and password.
2. Click the Administration link. Then click Application Security. The Application Security screen displays.
3. Select the User Maintenance function. The Registered Users screen displays a list of users you created.
4. Click the user name that requires a change. The Business Partner User Maintenance screen displays.
5. Click the button for the action that you require: Back, Edit, Change Password, or Delete.
 - Back: Takes you back to the previous screen.
 - Edit: Displays the information for the user you selected, in editable format.
 - Change Password: Prompts you to enter and verify a new password and sends an email notification to the appropriate user.
 - Delete: Removes the user's security rights and their name from ECMS.
6. Take the necessary action then click Save & Exit. The ECMS login screen displays.
