### **PennDOT's Utility Relocation Management System** Launching November 22, 2020

PennDOT's new Utility Relocation Management System (URMS) will launch on November 22, 2020. In Volume 3 of this newsletter, we highlight some of the ways that URMS enables PennDOT and Utilities to share mutually beneficial information.

## **URMS Enables Greater Information Sharing**

PennDOT operates many computer management systems that collect data and guide business processes. URMS brings together relevant data from many of those systems and presents it in a way to assist the utility coordination and relocation process.

### Link to One Map with a Customized Display

In recent years, PennDOT has launched, and continually improved, its One Map system. One Map provides a map-based system to view PennDOT projects overlaid with a wide assortment of other location-based data. The URMS One Map links goes directly to a zoomed in view of the project, with a custom set of map information layers.

In addition, PennDOT data can be downloaded from One Map to allow users to feed the information into their own GIS systems for analysis.



## Bridge Occupancy License Information



Utility facilities that are attached to a bridge are required to have a Bridge Occupancy License. URMS retrieves information about any existing Bridge Occupancy Licenses for bridges within the project limits.

#### Highway Occupancy Permit Information



Highway Occupancy Permits are issued for any utility facility within the state-owned right-of-way. HOPs may be issued as part of a PennDOT bridge or highway project or as standalone work performed by the utility.

URMS retrieves historical HOP records (open and closed) and displays it as part of the project location information.

The main Project Information page in URMS has a direct link to the environmental documents that were prepared for the bridge or highway project. These documents become important when permits are required

for utility facilities located in areas controlled by state or federal environmental regulations.
