Session co-facilitator Paul Caulfield opened the meeting and presented the following meeting objectives:

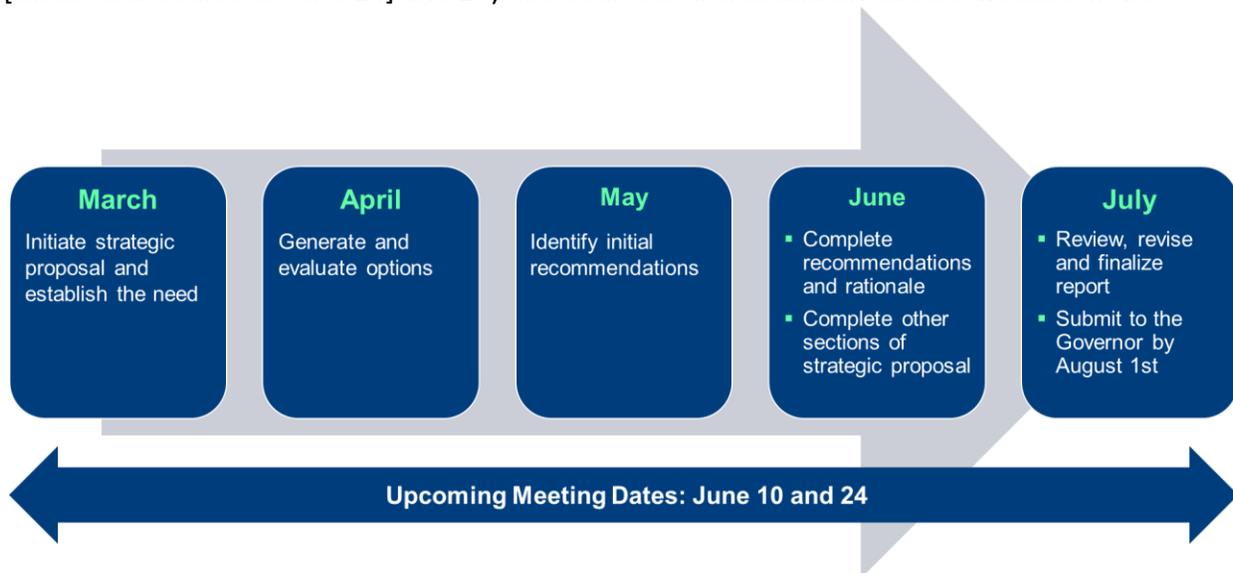
- To kick off the approach for evaluating revenue options scenarios

## Commission Chair’s Opening Remarks

Commission Chair Gramian thanked Commission members for their work to date. The Chair noted the importance of today’s MBUF and highway and bridge program presentations, emphasizing that this is foundational information prior to developing revenue scenarios. Finally, Chair Gramian emphasized that the future sustainability of our transportation system will depend on Commission members envisioning and leading change in accomplishing the charge of the Executive Order.

Paul briefly reviewed the overall schedule (below), noting that the June meeting dates (June 10 [since rescheduled to June 14] and 24) had been confirmed and invitations would follow.



## Projection Tool Demo

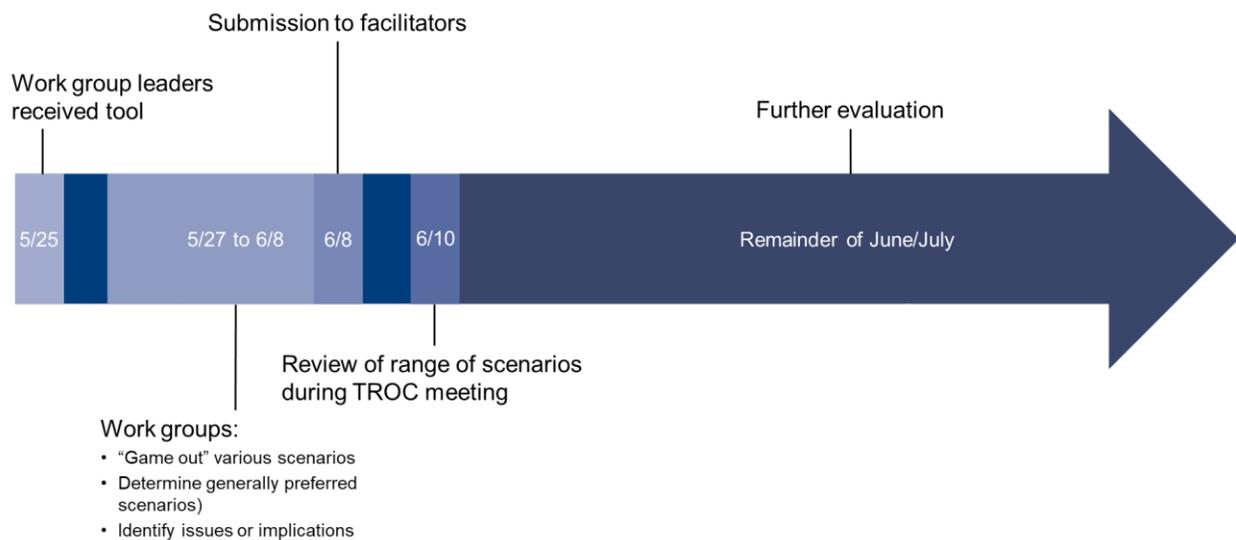
After a brief overview of the approach, Chuck Zimmerman provided a demonstration of the Revenue Options Calculator. The tool allows work groups to quantitatively project the impacts of various revenue options on funding needs. The tool had already been provided to Work Group Leads to allow them to familiarize themselves with its functions, time permitting. It was designed to enable them to “game out” scenarios with their groups. Additional directions for this activity would follow, and the Department’s subject matter experts Chuck Zimmerman and Nathan Reese would avail themselves to the groups for technical support.

## High Potential Options Discussion

While this agenda item was not covered in detail, owing to the time dedicated to the review of the tool, a few participants entered suggestions in Mentimeter. These have been recorded separately and will be included in subsequent discussions of the options of the highest potential.

## Briefings

Briefing 1: Patricia “Trish” Hernden, Ph.D., Executive Director of the Eastern Transportation Coalition provided an informative presentation on emerging practices in mileage-based user fees. Trish has worked on this topic intensively for years and offered a perspective on the latest findings from industry research and trial projects in other states. Her complete presentation is available on the website.

Briefing 2: Mike Keiser, P.E., Acting Deputy Secretary for Highway Administration of PennDOT provided a presentation on state-owned highway and bridge assets. Mike provided a perspective on the recent funding levels (2010 – 2022) and the needs of highways, bridges and the associated maintenance. He also discussed the volume of the Annual Program and the outlook for increasing it from \$2.5 billion to \$3.0 billion.
